Replace "Visitors are welcomed with aloha,"
With "Quality of life for residents is a priority"

Goal: Responsible Stewardship

Existing Policy:

In new subdivisions, streams and wetlands shall be delineated and preserved as open space.

Replace with:

Protect ocean and stream water quality by requiring that wetlands be preserved with vegetated buffer areas that are adequate to protect them from pollutants.

Areas of Change:

Challenges and Opportunities(pg 98)

...Not all of the lands will be acquired and managed by the County, however, any addition of new land to the County's park system requires additional funds to maintain the lands.
